



Took in 1,576 animals. 238 animals were adopted, 878 transferred to other cities/states, and 243 were returned to their owners. All animals taken in were vaccinated, dewormed, and given any necessary veterinary care. All 238 animals which were adopted were spayed or neutered. Trap/Neuter/Return program for feral cats: 161 cats were trapped, spayed or neutered, and returned to their outdoor habitat.
