Operate an animal shelter for the City of Las Vegas and the County of San Miguel, New Mexico. Took in 1,471 animals. 277 animals were adopted, 770 transferred to other cities/states, and 286 were returned to their owners. All animals taken in were vaccinated, dewormed, and given any necessary veterinary care. All 277 animals which were adopted were spayed or neutered. Trap/Neuter/Return program for feral cats: 244 cats were trapped, spayed or neutered, and returned to their outdoor habitat. Provided free or low-cost (\$25) spay/neuter services to 201 owned animals. Achieved 93.6% live release rate, representing a 2.16% increase over 2017.
