Operate an animal shelter for the City of Las Vegas and the County of San Miguel, New Mexico. Took in 1,528 animals. 215 animals were adopted, 744 transferred to other cities/states, and 346 were returned to their owners. All animals taken in were vaccinated, dewormed, and given any necessary veterinary care. All 215 animals which were adopted were spayed or neutered. Trap-neuter-return program for feral cats: 235 cats were trapped, spayed or neutered, and returned to their outdoor habitat. Provided free or low-cost (\$25) spay/neuter services to 340 owned animals. Achieved 89.8% live release rate, representing a 3.8% decrease over 2018.
